### TREASURER'S REPORT-BILLP

In General Account: \$18,145.75 as of May 31st

In Gaming Account – 4,103.19 less outstanding cheques

Half of gaming grant was not spent due to Covid-19 and will be carried forward to next year

Fun Lunches: donated to the Food Bank \$400 donated from Teacher's Gift Budget, \$362 from Hot Lunch refunds from parents. Remaining Money from Hot Lunches will be refunded to parents at the end of the school year.

Supplementary resources for teachers: Cheque for \$1,400 given to school

Motion to allocate \$100 to give to Ms. Silva's Project the Wishing Tree - Ashley S. 1st. Bill P 2<sup>nd</sup> PASSED

From Gaming Acct. \$1,005 was spent for 5 Divisions this year for field trips

\$900 from Gaming Grant will cover the Grade 7 leaving ceremony décor. Any remaining funds to be put towards the purchase of the legacy bench.

\$2,983 was fundraised by Gr. 7 parents and will be used towards the purchase of Grade 7 memory photo books. Remainder of legacy bench purchase (flat top stone bench from Northwest Landscape), donation to the Greater Vancouver Food Bank \$550) and the purchase of \$10 gift cards for each of the Gr. 7 students- \$450.
